### \*\*\*Negotiations Update\*\*\*

Residential—The Chapter and Local 8 have reached a tentative agreement for a new residential agreement. The Chapter and Local 8 will both hold ratification meetings on April 19, 2017 at 5:00 pm. Our meeting will be in the Electrical Industry Building. Please call Lisa Stichler if you plan to attend so we know how many will be in attendance.

<u>VDV</u>—The Chapter and Local 8 have had four negotiations meetings regarding the current VDV agreement which expires on April 23, 2017. We have another negotiation meeting scheduled on April 18 to try to reach a local agreement. Paperwork has been requested to file for Council on Industrial Relations (CIR) should we not be able to reach a settlement. CIR is scheduled to hear cases May 8-11, 2017. We will give an update on this at the membership meeting this month.

### A Foreman's Guide to Developing Your Workforce

The Southeastern Michigan Chapter has invited us to participate in a one-day Foreman class they will host at their facilities at 2735 Bellingham Dr. Troy, MI from 8am to 4pm on May 9, 2017.

Registration is 7:30 am. This class was offered in February and, due to the high turnout, they have graciously offered it again. The class will be taught by Nic Bittle who is the founder of Work Force Pro and an excellent presenter. A continental breakfast and lunch will be provided. I have attached some background information and a registration for this class (the pdf is formatted for you to fill it in). The Board of Directors authorized the Chapter to pay the cost for one employee to attend per member contractor. You may send additional employees if you would like, but the price will be based on attendance with a maximum of \$350.00 per person. We will pay the Southern Michigan Chapter, on your behalf, for each additional person to attend and then bill you based on the charge from the Southeastern Michigan Chapter. The deadline to submit registration to our office is April 28, 2017 by the end of the work day.

### BIG Changes at the City of Toledo Division of Building Inspections

On April 5, 2017, the Electrical Board of Controls held a meeting for the City of Toledo. Julian Highsmith, the commissioner for the Division of Building inspectors reviewed several major issues and changes:

- Dave Golis and the plans examiner have taken position is in the Lucas County inspections department.
- Toledo hired a staffing agency that assigned Tom Hall to fill the position held by Dave Golis until a permanent replacement is found.
- Toledo also hired a staffing agency that has multiple qualified plan examiners to use until the city is able to hire two plan examiners.
- Journeyman licensing renewal has ben extended until May 1, 2017. There are 1,000 licensed journeymen who have yet to renew this year. We ask all contractors to check that their journeymen have renewed licenses.
- Julian Highsmith also asked for patience as they go through this transition. He believes plan review will
  actually be quicker. If there are any major issues, he has provided his personal contact
  information and has pledged to assist when needed. Mr. Highsmith has assured us the department is
  open for business despite staffing departures.

Dear Safety Committee Members,

I just received this from the AGC Of Ohio:

OSHA Delays Silica Enforcement Enforcement Begins on Sept. 23, 2017

On April 6, the U.S. Occupational Safety and Health Administration (OSHA) announced that it will delay enforcement of the respirable crystalline standard for construction for three months-until Sept. 23, 2017. In its announcement, OSHA explained that the construction silica standard has a number of unique features warranting development of additional guidance and educational materials before enforcement begins. AGC continues to believe that implementation of this standard is technically infeasible and continues to challenge it in court.

Although OSHA enforcement of the standard is delayed, the notice does not alter the compliance date of June 23, 2017. OSHA will not take enforcement action against contractors that fail to meet the standard on their sites between June 23, 2017 and Sept. 22, 2017, but legally, the standard will still be in effect.

While an interested group could file a lawsuit challenging the three month delay, that appears to be unlikely given the short duration of the delay and the broad enforcement discretion federal agencies-like OSHA-have traditionally enjoyed. AGC will continue to fight this standard in court and advise OSHA on the problematic issues the construction industry faces with implementation.

### \*\*\*\*ATTENTION INSIDE APPRENTICES 1st through 3rd Year\*\*

We will be implementing NEW WORK REPORTS starting in the month of January. The instructors will be reviewing all changes with you. This change is in an effort to get a more accurate depiction of the apprentice's On the Job Training (OJT) hours. The New apprentice work reports are going to be used for the 1<sup>st</sup> through 3<sup>rd</sup> year inside apprentices. The 4<sup>th</sup> and 5<sup>th</sup> year apprentices will be using the old work report until they graduate. Journeypersons will be responsible for signing the weekly hour's verification on the report and scoring the apprentice on the back of the report. The foreman will also be responsible for scoring the apprentice on the back of the report. After the report is filled out the apprentice will deliver the work report to the JATC, and not to the employer. Employers may request a copy of a work report of any apprentice in their employ.

### \*\*NEW WELDING CLASS\*\* SHIELD METAL ARC WELDING (SMAW) Certification Class PLEASE SEE JOURNEYMEN ED CLASS SCHEDULE FOR DATES & TIMES

This new class was developed in accordance with AWS (American Welding Society) D1.1 Welding - Structural Welding Codes and Procedures. The SMAW Certification is made up of 3 courses totaling 160 Hours with learning outcomes and testing that are required to be met with each course.

(64 Hours) SMAW Certification Course #1 – SMAW Basic Flat, Horizontal, Vertical & Overhead (48 Hours) SMAW Certification Course #2 – SMAW Vertical and Overhead Structural Welding (48 Hours) SMAW Certification Course #3 – Structural Plate Certification – Vertical & Overhead

Guidelines for Journeyperson Education and Grant-In-Aid updates who are IBEW members not belonging to local eight, but on referral from IBEW local eight may take classes having to pay \$6.00 per hour of class time and only be eligible for safety related classes.

    properly register ahead of time, your name will not be on the roster; therefore, there will be no certificate or grant-in-aid check
    for you (assuming your eligibility).
  - Please remember that class numbers are limited; this means that if more than the limit registers, a lottery will be held two
    weeks before the start date of that particular class. Please pay particular attention to your calendars so that you have an idea

### **GRANT ADJUSTMENTS & CRITERIA**

### **COURSE FEES**

Some of the courses at the JATC require books and materials that have to be purchased *before* the start of the class and, at times can be very expensive. We have made adjustments so that if possible these fees can be subtracted from the grant-in-aid at the end of the course; however, there may be instances that you take a job call or, just cannot attend or finish a particular class; whatever reason, you will be responsible for the cost (s).

<u>FEES REGARDING BICSI CLASSES:</u> the Cabling Manual and the workbook(s) fees *MUST* be paid *BEFORE* the start date of the class you have registered for.....the cost of the Cabling Manual is \$200; the workbook is \$80. Therefore, before you can attend class, *please* be prepared to come in to the JATC office to pay the \$280 fee. BICSI LEVEL II (Copper + Fiber) is a cost of \$360 to be paid at the beginning of class.

more to fear from our own actions than from any other job hazards around us. Why do we deliberately expose ourselves to injury every day? Most of us know that accidents are caused by only two things - unsafe acts or practices, and unsafe conditions. Some of us even know that 9 out of 10 accidents are the result of unsafe acts, or things we do when we know better. This is kind of strange if you think about it. We have

We take shortcuts.

Some of us are fairly meticulous about following safe work practices, but because a job "will only take a minute" we use an unsafe method or tool. For example, not putting on our PPE because the job will only take a minute, or not putting the machine in ESP because an adjustment will only take a second.

Rushing is one of the main causes for taking shortcuts. No task is that important that it can't be done safely. Yes, we all have goals and objectives to meet, but more importantly is that we meet them the same way we started . . . with all our parts intact.

Frustration is another cause for taking shortcuts. We get frustrated with machines, people, processes and rather than stopping and thinking... we just do it. We get so wound up in the moment we don't look at the things that are important.

### During the spring nesting season, geese can be aggressive. Here's how to reduce the risk.

Nest Strategies...

Erect temporary fencing and use caution tape to create a no-go zone

Inform employees of the location to avoid

If you can't let nature take its course, contact ODNR for goose damage permits

Place signs to discourage people from feeding the geese



Although employees may enjoy watching their antics, geese are wild animals and they will ferociously protect their young.

During nesting season, females are vulnerable on the nest and males defend them. In the wrong spot, both pedestrians and vehicular traffic seem threatening to the proud papa. He will charge towards the threat – bringing fifteen pounds of fury – creating the potential for injuries.

Adult geese weigh 6 to 18 pounds and have strong chests and wing bones, which are capable of inflicting serious damage. A more frequent hazard is when people trip, fall, or drop what they're carrying when suddenly attacked by a goose.

Geese will also attack vehicles, increasing the chances of collision and injury.

If you are threatened by a goose:

- Stare down your attacker. Don't squint or close your eyes.
- Slowly back away; do not turn your back. Maintain eye contact with the bird.
- Don't act hostile by kicking or hitting towards the goose; this will agitate him further. And the female may leave her nest to join the attack.
- If a goose flies towards your face, duck or move away at a 90 degree angle while still facing the goose.
